
# COMPUTERIZING THE PROCEDURES FOR BUSINESS REGISTRATION, TAX CODE REGISTRATION AND SEAL MAKING

The need to manually process business registration paperwork is now history. With **BusinessPortal** the procedures for business registration, tax code registration and seal making can be processed by computer at DPI, the Tax Agency and the Department of Public Security.

The computerization of the procedures for business registration, tax code and seal registration and other public services are the foundation for the offering of these services online through the Internet.

#### ON-LINE REGISTRATION OF BUSINESS, TAX CODE AND SEAL

Implemented successfully in many provinces, BusinessPortal proves to be an efficient tool which enables enterprises to submit their dossiers on business registration, tax code registration and seal making on-line. With a computer and an Internet connection businesses can access these services easily and conveniently, anytime and anywhere. Relevant local government agencies can process these procedures via the Internet with high level of security.



BusinessPortal is the pioneer product which provides solution to the coordination mechanism in providing business, tax code and seal registration as required by the inter-ministerial circular No. 05/2008/TTLT/BKHDT-BTC-BCA dated 29 July 2008. BusinessPortal makes it possible to share electronic business registration dossiers and files submitted by enterprises, providing the foundation for coordination between the three agencies when processing market entry procedures for enterprises. The software in the portal enables the circulation of dossiers between the business registration office, the tax agency and the provincial public security department without requiring them to sit in the same office.

# SOFTWARE FOR HOUSEHOLD BUSINESS REGISTRATION IS DEVELOPED AND IMPLEMENTED AT DISTRICTS

The software for household business registration at districts is also developed as part of **BusinessPortal** and has been successfully implemented in many provinces. The software also allows the computerization of business registration at districts and the smooth link with the provincial portal for the purpose of an on-line household business database.

### ON-LINE INVESTMENT PROJECT REGISTRATION IS ALSO PART OF THE BUSINESSPORTAL

BusinessPortal has been updated with the On-line Investment Project Registration module. The new module enables enterprises and investors to register their investment project online, thus reducing the costs and time which they need to spend on these procedures.

# A POWERFUL AND MULTI-PURPOSE ON-LINE DATABASE OF ENTERPRISE, HOUSEHOLD BUSINESSES AND INVESTMENT PROJECTS

BusinessPortal integrates an on-line database of all the enterprises registered under the Enterprise Law in the province. The database is open to the public and is updated automatically. Search of enterprise information is extremely easy on the database.

Upon request, the databases of household business, and of investment project can also be developed on-line as part of **BusinessPortal**.

### AUTOMATIC EXPORT OF REPORTS ON ENTERPRISES AND INVESTMENT PROJECTS

Statistic tools of **BusinessPortal** allow government users, especially DPI and other provincial agencies, to use the continuously updated databases to generate reports
